**Partners for Clean Streams continued to support the Maumee AOC Advisory Committee activities with two grants from Ohio EPA. We planned & facilitated meetings, organized and led community engagement & education, and continued improving and maintaining a sophisticated online data management and decision making tool (DMDS). We organized tours of local restoration projects and on the Maumee River, we updated the 2 websites & social media accounts, and we develop educational materials. We worked with many partners to develop a set of projects that when fully funded, would address local environmental impacts.**

**Partners for Clean Streams continued a NOAA marine debris reduction & removal grant. With this grant, we led many stream cleanups throughout the greater-Toledo area to remove 21,273 pounds of trash with the assistance of 1087 volunteers. We partnered with Metroparks Toledo & Wood County Parks to take volunteers out to islands in the Maumee River for paddle cleanups, reaching areas that we don't often get to on our own. We developed marine debris prevention materials and distributed education & prevention information via social media, in person, to volunteers, and through our website.**
